**Inclusion in/exclusion from the Second Schedule to the Reserve Bank of India Act, 1934-
Regional Rural Banks (RRBs)**

We advise that the names of five Regional Rural Banks have been included in the Second Schedule to the Reserve Bank of India Act, 1934 by notifications RPCD.CO.RRB.BC.No.76/03.05.100/ 2013-14 dated January 27, 2014, RPCD.CO.RRB.BC.No.94/03.05.100/ 2013-14 dated April 9, 2014 and RPCD.CO.RRB.BC.No.98/03.05.100/ 2013-14 dated May 8, 2014, published in the Extraordinary Gazette of India (Part III - Section 4) dated May 24, 2014 and July 25, 2014.
